RE: Highway Trees : HMPE

Further to our cyclical tree condition survey, ODS are planning to undertake the attached tree works within your ward.

The attached works orders have been identified due for either health and safety, statutory clearance of a highway/footpath and arboriculturally best practice.

A tree is only highlighted for felling through routine inspection if it is identified as:

- Dead
- Dying
- Diseased
- Dangerous and is posing an unacceptable risk to public safety.

- Damaging property (e.g. subsidence when confirmed by technical evidence) as per the [Tree Management Policy | Oxford City Council](#)

Some of these works are dependent on planning restrictions and authorisation by the responsible department.

The tree works are taking place now. if you have any concerns, please email the Tree Team inbox ([tteam@oxford.gov.uk](mailto:tteam@oxford.gov.uk)) to discuss these further.

## Tree Planting

If trees are identified for removal then our aim is to replace them where appropriate which may not be in exactly the same position (please note highway trees will not be replaced as we do not receive a budget for tree planting on highway land). Any replacement planting will be undertaken between November and March and according to our 5 year tree planting schedule shown below.
